CHAIRMAN'S REPORT

Council matters are in full flow after the recess and by the time you read this, we should know the final decision from Mid Sussex District Council regarding whether Worth Parish Council should split or not. Whatever the decision, there will be a lot of work for the Council to do. Obviously if the decision is to split there will be months of work to separate the financial, asset and employment aspects of the existing Council, but even if we do not split there will likely be a re-launch of the Council name and identity to handle as well as looking at the relationship between the two villages following such a major event. I am confident that with the help of our excellent Officers and my fellow Members we can achieve what is required regardless of the outcome. I also look forward to putting this behind us and progressing with the challenges of achieving the vision and goals set for our villages without the distraction.

I am extremely proud to announce that we have successfully promoted one of our existing Groundsman to a Supervisor role as part of our next initiative to improve the Council infrastructure. Having this Supervisor position will give us motivated 'eyes and ears' to look at the landscape of our villages and how we can improve them for existing and future residents. I am confident that alongside the partnership we have signed with West Sussex County Council, we can start to ensure both villages get the facelift they deserve and the maintenance to preserve the new look. We will keep you informed of new initiatives as they appear and look to you all for ideas on how we can maximise this opportunity.

We had the Purple Bus event on the Copthorne Village Green recently and the response to this was amazing. It gave us an opportunity to inform locals of what we are trying to achieve going forward to support our youth. Unfortunately, this has coincided with one of the founders of the new Copthorne Youth Club standing down due to personal commitments, so we are now urgently seeking someone to take over the mantle to keep this most important initiative moving forward. If any of you are willing to discuss this, please contact our Clerk to express an interest and I assure you that you will receive as much support as you can get from the Council Officers and Members.

On a similar note, the Copthorne Working Party has been discussing recent problems with car theft and attempted burglaries. This has prompted a desire to step up the Neighbourhood Watch initiative to ensure these issues get the local focus they warrant. We are also moving into the budget phase of the Council to set the budget for next year (2023-24). This may sound very premature, but it is a lengthy process that takes a lot of managing. EIGHT ACRES OF LAND URGENTLY NEEDED FOR SPORTS FACILITIES IN COPTHORNE

COPTHORNE MEN'S TEAM TO HOST FA CUP MATCH! Wouldn't it be great if this were to happen? But at the moment it can't. In the season that has just started, Copthorne Football Club men's first team are having to play home matches at Horsham and Acorns Copthorne Ladies Football Club first team are having to play home matches at Lingfield. This is so they can progress up the football pyramid as we do not have the land and facilities in Copthorne that they require to compete at a higher level.

In September 2012, Copthorne women's team did play an Emirates FA Cup match at King George V Field in front of 200 spectators and later in the season entertained and beat Leyton Orient, but this could not happen at the moment due to higher FA ground requirements.

It is not just about teams playing at a higher level, it is very much about children's and grassroots football. We have boys' teams in the village from under 6 to under 18, we have four girls' teams, and this is growing with the success of the national women's team in the recent Euro's, we have four men's teams and three women's teams.

We currently have one adult pitch and one youth pitch in Copthorne to try and accommodate the home fixtures for these teams. This results in the football clubs spending many $\pounds'000$'s in Crawley, East Grinstead, Lingfield and Horsham for pitches and training facilities. Wouldn't it be better if this money was being spent in Copthorne to improve and expand sports facilities for not just football but sports generally in Copthorne?

We are in the fortunate position through contributions from the housing development going on to the west of the village and the generosity of residents in the village who are, for a limited period, prepared to finance the building of a new facility to the standard that would enable our teams to return to the village. This would enable to build a full-size artificial training pitch which would also be suitable for other sports and a new football pitch with the necessary changing rooms, floodlights and other requirements. Not only would we redirect the money that our teams are spending elsewhere back to Copthorne, but we would be able to hire the facilities to clubs outside the village, thereby earning more funds to develop sport and recreation in Copthorne.

ALL WE NEED IS EIGHT ACRES OF LAND! If anyone is aware of or owns land that could be purchased or leased for a long period within Copthorne, the Parish Council and the football clubs would love to hear from you.

There will be others who, for a variety of reasons, are more difficult to identify – such as those who live in the community as individuals, visitors to the area or the homeless. Contingency arrangements are needed to ensure they are not overlooked. Therefore, Worth Parish Council will hold a list of vulnerable individuals in the Parish. So, if we are faced with a local emergency, we can ensure that we help those who need it most. SAFE AND WELL VISITS, WEST SUSSEX FIRE & RESCUE SERVICE

Samantha Barber is the new Rural Engagement Officer for West Sussex Fire & Rescue Service offering free Safe and Well visits. This service supports vulnerable residents ensuring they are fire safe at home.

They advise on important aspects of fire safety including testing smoke detectors to ensure they are working and talk about how to reduce the risk of fire in the home including kitchen fire safety, electrical fire safety, safe heating practices, smoking cigarettes safely and escape plans. They can supply free equipment such as smoke detectors, deaf alarms and also provide equipment to protect you when you are smoking in your homes.
