2. Public Question Time

To receive, and act upon if considered necessary, comments made by members of the public. This item will last for a maximum of 15 minutes with individual contribution up to a maximum of 3 minutes.

Members of the public are welcome to ask questions of the Council on matters that arise under its remit. The question should not be a statement, and it would be appreciated to be kept short, to maximise the time for other questions. The Chair will call the question from those who are indicating that they wish to speak.

Members of the public will only be allowed to speak at any other time during the meeting at the discretion of the Chair, and will be governed by the rules set out in the Council's Standing Orders at all times.

- 4. Declarations of Disclosable Pecuniary and Other Interests to receive any declarations of interest from Councillors.
- 5. Minutes to approve the Minutes of the Amenities & Assets Committee meeting held on 17th March 2025 (attached).
- 6. Chairman's Announcements to receive any announcements by the Chairman of the Amenities & Assets Committee.

7. Allotments - to note that:

- a. Allotment inspections took place in May, with 23 plots being identified as needing to be worked.
- b. A standpipe at the allotments is no longer required.
- c. The Heathy Wood allotments are still being constructed. No handover date has been discussed yet. The developers are struggling to get a water supply to the site.

- 10. **Street lights** to **note** that there is approximately £30,000 worth of work remaining to finalise all of the repairs. The majority of this work will now take place in the next financial year.
- 11. **Council and Community Assets** to **receive** any update as to the responsibilities of the Council in relation to Council-owned land and assets.
 - a. To **consider** recommending to the Finance & General Purposes Committee purchasing a new defibrillator at an approximate cost of $\pounds 2,000$, to be paid from the Capital Purchases budget. The Crawley Down defibrillator is no longer compatible with the new batteries being provided. Funding can be sought for this.
- 12. **Council Premises and Land** to **discuss** and **comment** upon matters relating to Councilowned, leased or managed land and buildings.
 - a. To **approve** the Estate Management Plan (attached)
 - b. To **note** that Swish Fibre has offered a payment of £750 for a wayleave agreement to site their cabinet on land in Crawley Down. The agreement and amount is currently in negotiation as legal fees will be approximately £750.
 - c. To **note** that the trees on land next to Francis Court have been surveyed, and one dead limb has been removed.
