028 Public Question Time

Inspector Derrick has been in post over two years and is responsible for Mid Sussex. This is a huge area to cover, but has one of the lowest crime areas in Sussex. The main challenges are the scale of the area and resources available to them.

Most of the rural areas are very low in crime.

Statistics were given for the East Grinstead area, which highlighted that most of their emergency calls are related to domestic abuse. They have had a 20% increase in thefts, which is partially related to their new reporting system but it was noted that they do see an increase in thefts in times of austerity.

All councillors are welcome to have Insp Derrick's contact details.

The following issues were raised:

- Anti-social behaviour and criminal damage at Crawley Down Pond. Insp Derrick advised that this should always be reported. The area Sargeant sees all reports and uses them to make decisions on where patrols will be sent. Reports can be made to 101 anonymously if needed.
- Groups of children congregating outside shops which causes concern locally.
- Electric scooters and bikes it is illegal to use these on any public area (e.g. roads and pavements). Passing Police will not pull over people using these as they won't create a 'chase' situation which could result in injury.
- Hotels housing immigrants/refugees crime statistics show that crime is higher in Copthorne than in Crawley Down, is this linked to Copthorne Hotel? Insp Derrick reported that there are around 11 hotels in the area housing 1,500-2,000 of the vulnerable people in the world. They receive weekly visits from PCSOs and their contact with them is positive. Statistics do not show a rise in crime linked to these hotels.
- If a child is found with alcohol, the Police do follow up where this is from.
- Morrisons in Copthorne has been burgled four times in the last month. This is common at the moment. Businesses are encouraged to increase their security. Personal burglaries are a priority over business burglaries.

Worth Parish Council is rolling out CCTV and Insp. Derrick was asked his views on this. He stated that CCTV is a really useful deterrent.

040 Copthorne Recreation Ground

It was RESOLVED to:

- a. Subject to the approval of the S106 applications submitted, approve the revised budget as recommended by the Finance & General Purposes Committee. The total budget for the project is £651,633.85 plus VAT and will be funded as set out in the report.
- b. Approve the use of earmarked reserves as recommended by the Finance & General Purposes Committee:
 - £10,276 from the Copthorne Recreation Ground fund £5,000 from the Lashmere fund £20,000 from the CCTV fund
- c. Subject to the approval of the S106 applications submitted, seek approval of the Secretary of State for the Ministry of Housing, Communities and Local Government to apply for a Public Works Loan of up to £150,000 over the borrowing term of 10 years to part fund the Copthorne Recreation Ground Rejuvenation Project, as recommended by the Finance & General Purposes Committee on 2nd September 2024. It was noted that the loan amount applied for will be reduced if funding/donation/sponsorship applications and requests are successful.

It was RESOLVED to:

- a. Approve the strategy for maximising use of S106 funds.
- b. Implement the process for determining future needs & communicating this to the Planning Authority.

042 Communications

- a. Parish Awards it was agreed that the Village Working Parties should consider the best way of getting nominations and deciding on the winner.
- b. It was noted that surgeries are taking place on 22nd July in Copthorne (Olivers) and 27th August in Crawley Down (outside shops) in conjunction with the PCSO and Age UK.

043 Personnel

It was RESOLVED to exclude the press and public from the meeting for this item in accordance with the Public Bodies (Admission to Meetings) Act 1960 s1 due to the confidential nature of the matter to be discussed.

The report from the Chief Officer was noted. It was acknowledged that staff are currently working at capacity and the current TOIL/workload level is not sustainable in the long term, and the solution was accepted as a short term issue. It was RESOLVED to vire £8,000 from the Youth Staff budget to set up a new code for overtime. This can be used to pay off the accrued TOIL, and also allow overtime going forward so that work levels can be maintained.
